Identifying features

- Corpo oval quase em forma de losango;
- Olhos geralmente situados do lado direito do corpo;
- Barbatana dorsal começando acima dos olhos;
- Uma fiada de tubérculos ósseos na base das barbatanas dorsal e anal;
- Coloração da face superior castanha esverdeada;
- Barbatanas dorsal e anal do lado cego escuras.
